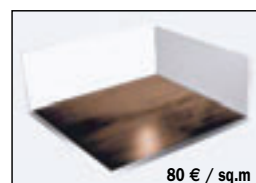

## REGISTRATION AND CONFIRMATION

Any party that wishes to take part in the event as a registered exhibitor must declare its firm and binding wish to take part by completing the exhibitor registration form in full, signing it and returning it to the event organiser. Incomplete registration forms cannot be accepted.

An agreement on the hire of the stand area and the participation of the applicant at the specified events shall come into effect only when registration has been confirmed in writing, or an invoice requesting payment has been issued by the event organiser (acceptance). In the case of registration for several events, the event organiser is not obliged to confirm the registration of the applicant for all the events in question simultaneously. If confirmation of registration for the individual events has not been received, this does not mean a final rejection of registration for the events. The event organiser reserves the right to issue acceptance at a later date and to ask for any documents they consider necessary.

After receiving the Exhibitor Registration Form and accepted it, FIRA DE BARCELONA will issue the applicant company with an invoice for the **INSCRIPTION FEE**, which must be paid upon receipt. FIRA DE BARCELONA will not process any Application until the Participation Fee has been paid. Under no circumstances shall any amount paid over by way of Participation Fee be refunded.
